On motion by Greg Duke, second by Louis Hatcher, the Board unanimously approved the certified staff for 2011-2012 school term (listed by school or assignment) and the 2011-2012 non-certified employment recommendation list.

First presentation of the 2011-2012 preliminary budget was provided to the Board.

On motion by Louis Hatcher, second by Robert Clay, the Board unanimously approved a request to provide a bus and driver to transport children for Lee County YMCA Summer Day camp at the rate of \$10 per hour/ \$2 per mile.

On motion by Robert Clay, second by Frank Griffin, the Board unanimously approved a contract with Kinney Construction Company for the LCHS cafeteria expansion. Dr. Clay asked if the fees could be negotiated. Dr. Walters said they are checking into it.

First presentation of PreK-8th grade school uniforms was presented to the Board. No action was taken. Mrs. Vann asked the school system to seek input from parents, students and the community before proceeding.

On motion by Robert Clay, second by Louis Hatcher, the Board unanimously approved a request to increase school lunches by 10 cents per year for 10 years. It is part of the Healthy Hunger-Free Kids Act of 2010 which requires School Food Authorities participating in the National School Lunch Program to provide the same level of support for lunches served to students who are not eligible for free or reduced price lunches as they provide to students eligible for free meals.

On motion by Frank Griffin, second by Louis Hatcher, the Board unanimously approved a request to continue and expand the Kiwanis backpack program.

The program will continue in the two primary school and expand to the two elementary schools.

On motion by Louis Hatcher, second by Greg Duke, the Board unanimously approved the following 6-8 summer school guidelines and night school component:

Lee County Middle School Summer School Guidelines

- 1. Summer school for grades 6-8 will be held at Lee County Middle School from 8:00-3:00 during the month of June for a two week period of time.
- 2. Students must pay \$175.00 to attend summer school.
- 3. Summer school is limited to students who attended LCMS during the previous school year.
- 4. Summer school is for promotion purposes.
- 5. A student may take up to two subjects in summer school.
- 6. The grade for the summer school course will be based on the work done in summer school. If the student passes all courses in summer school that need to be taken to be promoted, he/she will be promoted. A separate grade for the course taken in summer school will be noted on a transcript.
- 7. If a student fails three or more subjects, the student may not attend summer school. (Student must repeat the grade failed.)
- 8. Progress reports will be sent at the end of the first week.
- 9. The LCSS Code of Conduct and dress code will be strictly enforced.
- 10. Transportation to and from summer school is the responsibility of the student's parent/guardian. If bus transportation is needed, a form will be provided in advance of the end of school for the parent to complete.
- 11. Attendance is required for successful completion of summer school. Students may not miss more than two school days.

Night School component- expand summer school offerings through the use of NovaNet portals at TLC.

On motion by Louis Hatcher, second by Frank Griffin, the Board unanimously approved a request from LCHS student, Hugh Slaton III for additional non-instructional days.

On motion by Robert Clay, second by Louis Hatcher, the Board unanimously approved a request for LCHS teacher, William Swafford to take the debate team to Washington DC May 26-31 and Dallas, TX June 13-20, 2011.

On motion by Louis Hatcher, second by Robert Clay, the Board unanimously approved a request to waive local graduation requirements for LCHS student, Shivani Patel in order for her to graduate early. She will lose the opportunity to be valedictorian or salutatorian of her new graduating class.

First presentation of policy IHF (6) Graduation Requirements was made to the Board. Dr. Walters recommended since the high school is moving to a 7 period school day upcoming ninth grade students be required to earn 25 credits to graduate.
