Dr. Miller presented the following reports to the Board:

On motion by Claire Lang, seconded by Donna Ford, the Board unanimously approved the request to bid/purchase three 90-passenger schools buses.

On motion by Sylvia Vann, seconded by Trey Newell, the Board unanimously approved the FY 20 financial statement.

On motion by Claire Lang, seconded by Trey Newell, the Board unanimously approved 2020-2021 non-resident tuition in the amount of \$210 a month or \$1890.00 per student this school year.

On motion by Trey Newell, seconded by Claire Lang, the Board unanimously approved a temporary change to the definition of a long-term substitute teacher. Long-term substitute is now defined as 10 days instead of 20. The board also approved new temporary rate of pay for substitute teachers:

- Noncertified Substitute - \$83 per day
- Certified Substitute, long-term paraprofessional or clerical - \$87 per day
- Long-Term (at least 10 consecutive days) Substitute Teacher (not certified) - \$90 per day
- Long-Term Substitute Teacher (certified) - \$100 per day
- Retired Teacher sub (not certified) - \$100 per day
- Retired Teacher sub (certified) - \$105 per day

No further action, the Board meeting was adjourned.
